- Beah moves to amend the motion that SUNSCAD Council shall reach out to all three students via email asking what they need most in this time, whether it be donations of food, clothing, equipment, or money, Adia seconds, unanimous, amendment passed
- Chelsea moves to amend the motion to say "Aaron Abogado" instead of "SUNSCAD Council," Julien seconds, majority, amendment passed
- Miranda moves that Aaron Abogado shall reach out to all three students via email asking what they need most in this time, whether it be donations of food, clothing, equipment, or money, majority, motion passed

- Majority opposed to holding an in camera session, motion failed
- No vote occurred on budget

## Union dues

- Clem moves to adopt the following motion, Miranda seconds:
  - Whereas the cost of labor, operations, and materials continues to rise; be it resolved that SUNSCAD's union dues increase by 5% for the year of 2025/6.
- Caspian moves to amend the motion to mandate SUNSCAD to communicate the specifics of the change in union dues to all students within a month of it taking effect
- Owen moves to amend the amendment to say "within two weeks of today's date,"
  Caspian seconds
- Clem moves to adopt the following motion, Miranda seconds:
  - O Whereas the cost of labor, operations, and materials continues to rise; be it resolved that SUNSCAD's union dues increase by 5% for the year of 2025/6, and that SUNSCAD is mandated to communicate the specifics of this change to all students within two weeks of today's date
- Majority, motion passed
